Code Ann. §23-23-60: "An application under oath on a format prescribed by the director; evidence satisfactory to the director that the candidate has completed high school and received a high school diploma, equivalency certificate (military or other) recognized and accepted by the South Carolina Department of Education or South Carolina special certificate; evidence satisfactory to the director of the candidate's physical fitness to fulfill the duties of a law enforcement officer including: a copy of his/her medical history compiled by a licensed physician or medical examiner approved by the employer; a certificate of a licensed physician that the candidate has recently undergone a complete medical examination and the results thereof; evidence satisfactory to the director that the applicant has not been convicted of any criminal offense that carries a sentence of one year or more or of any criminal offense that involves moral turpitude. Forfeiture of bond, a guilty plea, or a plea of nolo contendere is considered the equivalent of a conviction; evidence satisfactory to the director that the candidate is a person of good character. This evidence must include, but is not limited to: certification by the candidate's employer that a background investigation has been conducted and the employer is of the opinion that the candidate is of good character; evidence satisfactory to the director that the candidate holds a valid current SC driver's license with no record during the previous five years for suspension of driver's license as a result of driving under the influence of alcoholic beverages or dangerous drugs, driving while impaired (or the equivalent), reckless homicide, involuntary manslaughter, or leaving the scene of an accident. Graduates for certification as Class II-LCO in any county that borders another state may hold a valid current driver's license issued by any jurisdiction of the United States; evidence satisfactory to the director that a local credit check has been made with favorable results; evidence satisfactory to the director that the candidate's fingerprint record as received from the FBI and SLED indicates no record of felony convictions; copy of the candidate's photograph; copy of the candidate's fingerprints; evidence satisfactory that the candidate's present age is not less than twenty-one years. This evidence must include a birth certificate or another acceptable document."

The documentation as required by S.C. Code Ann. §23-23-60 has been reviewed and deemed acceptable for admission of said candidate. Any graduate found to have deliberately falsified the application for training and certification while employed by his or her present, or any previous employer shall have his/her certification withdrawn by the Department in accordance with regulation Chapter 38-016.


